| Completed Short-Term Rental Application Form. (Application below)  |

| Proof of receipt of New York State STAR Credit Check, <b>OR</b> STAR property tax exemption or the short-term rental property (shown on Haldane School tax bill or receipt). |
| Proof of insurance on the proposed STR unit in the amount of at least \$500,000.   |
| Signed and notarized certification stating that the property is the owner's primary esidence. (Certification below)  |
| Initial application/registration fee: \$250.00   |
| Fire Inspection fee: \$100.00, payable to the Town of Philipstown  |
| If proposed STR unit has a shared driveway, must show proof of access easement or igned statement from shared driveway users consenting to guests utilizing the driveway.    |

\*Inspection will be arranged by the Village Code Enforcement Officer after application is reviewed.

Fees: Initial registration of STR unit is \$250

- Annual renewal of registration of STR Unit is \$150
- If needed, first re-inspection is free
- If needed, second or more re-inspections are \$50 each
- Fire Inspection fee of \$100, payable to the Town of Philipstown
