Resolution to approve Revocable License Agreement for use of a portion of the Village Right-of-Way on Healy Road for approved landscaping in front of 36 Healy Road

The Board of Trustees of the Village of Nelsonville met in open session on the 24th day of August, 2026, and adopted the following Resolution moved by Mayor Winward and seconded by Trustee Potts.

WHEREAS, The Village Board of Trustees has been presented with the attached Revocable License Agreement to allow homeowners, William Ladd and Ashley Hernandez of 36 Healy Road, to plant approved juniper bushes in the Village right-of-way in front of their home; and

WHEREAS, The homeowners of 36 Healy Road (the Licensees), shall comply with all applicable requirements, including keeping the License Area in an appropriate condition and repairing any damage to the License Area, including the guide rail, curb and asphalt immediately adjacent to the License Area, if caused by Licensee's use thereof; and

WHEREAS, Licensee shall be solely responsible for the maintenance of the Plantings so that they do not grow into the roadway; and

WHEREAS, The Village shall have no obligation to maintain, remove or replace the Plantings for any reason, including any Plantings that may be damaged or destroyed by the Village's maintenance of the roadway such as snow and ice removal;

NOW THEREFORE BE IT RESOLVED, That the Board of Trustees of the Village of Nelsonville authorizes the attached license agreement to be executed by the mayor for the Village of Nelsonville.
