CACCAMISE RESIGN IMMEDIATELY – ALSO STATES THAT THE  
TRUSTEE POSITION VACATED BY THE TRUSTEE BECOMING MAYOR  
REMAINS EMPTY UNTIL MARCH. CLERK TO CHECK THAT  
PROCEDURE.

MR ROBERTSON QUESTIONS SECOR ST.

LISA MECHALEY REHASHED HER MEETING WITH WIL NIEVES AND  
UPDATES THE PUBLIC. NO DECISION HAS BEEN MADE.

MR ROBERTSON CAUTIONS THE BOARD TO TRED CAREFULLY WHEN  
IT COMES TO THE SEWER THE ISSUE – DUE TO THE COST.....

FRANK CACCETTA EXPRESSES THAT THE SESSPOOLS AND THE  
SEPTIC SYSTEMS ARE SUFFICIENT – THAT WE SHOULDN'T PAY FOR

COLD SPRINGS SEWER SYSTEM WHEN AND IF NELSONVILLE HOOKS UP.....THERE IS NO REASON TO LOOK INTO SEWERS.....

ALAN POTTS ADDS THAT IF THE SEWERS COME IN, IT OPENS THE VILLAGE UP TO MULTIPLE DWELLING UNITS.....

DONALD GRAHAM BRINGS UP THAT KENT PASSED A LAW THAT RESIDENTS MUST CLEAN THEIR SEPTICS EVERY TWO YEARS.

FRANK CACCETTA AGAIN BRINGS UP THE SEWER PRICES – AND UNIONS, ETC..... WHAT A WASTE OF TIME IT IS TO EVEN LOOK INTO IT.....

GLORIA VANTASSEL IS UPSET AT MAYOR CACCAMISE RESIGNATION AND ALSO SUGGESTS WE GET AN APPRAISAL ON THE SECOR ST PARCEL.
